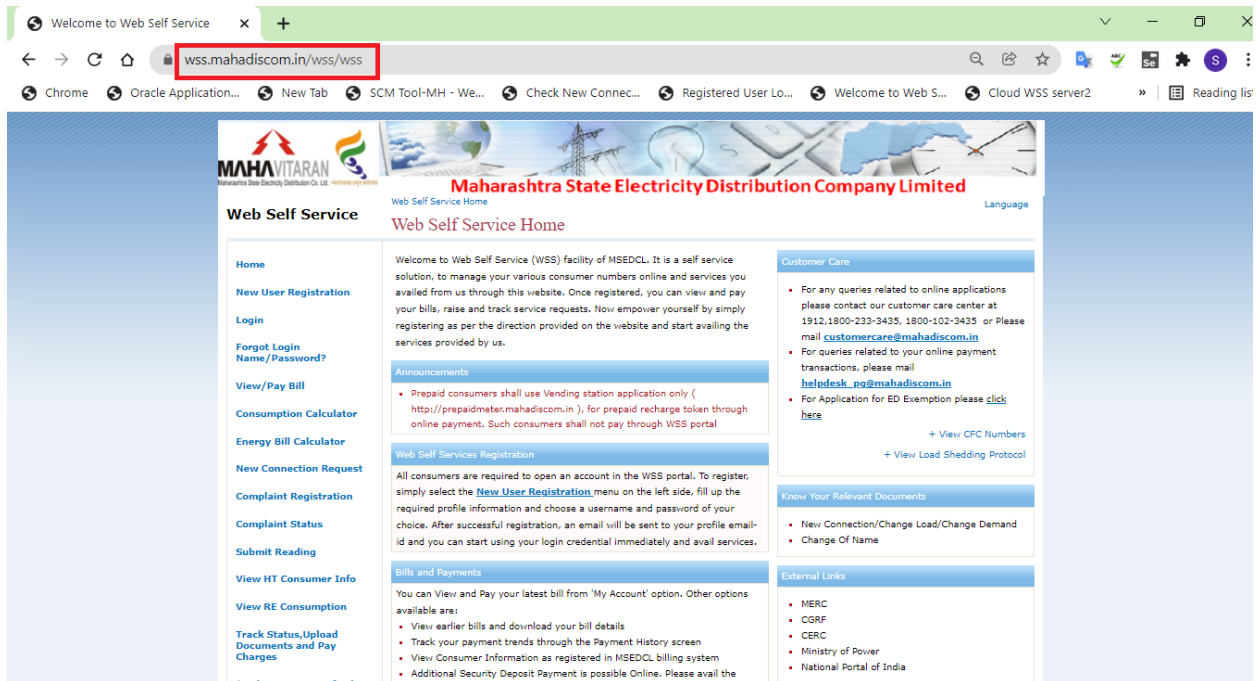
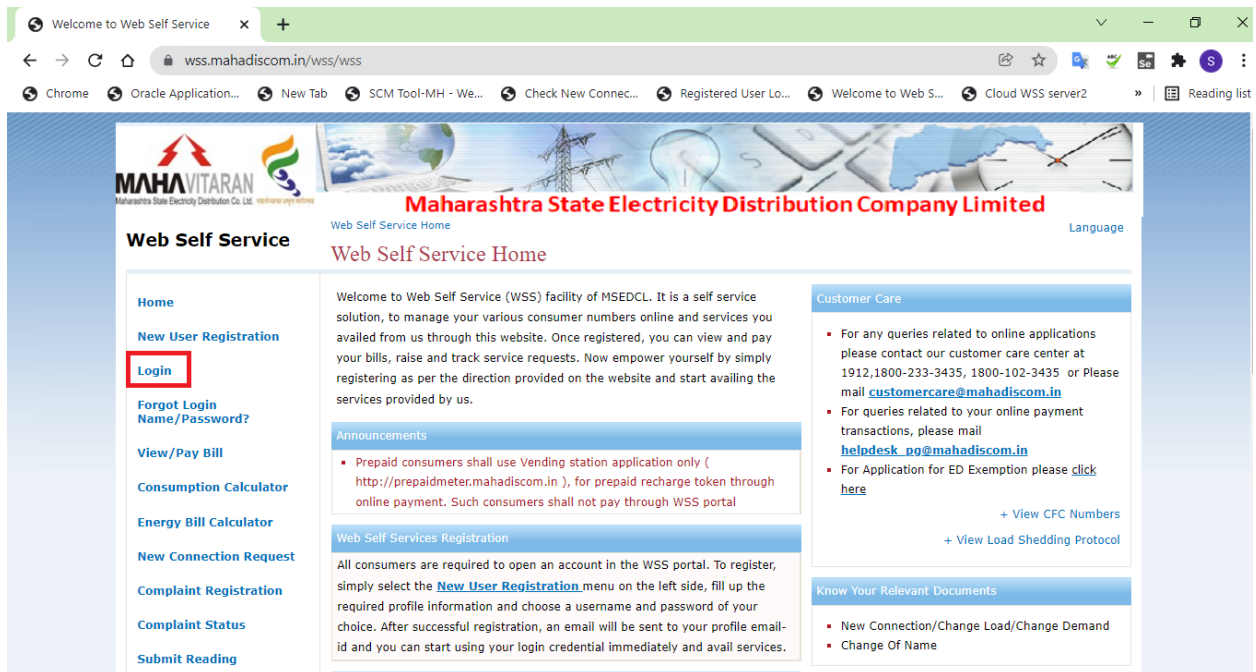


Help Manual for Shri Vilasrao Deshmukh Abhay Yojna (PD Amnesty Scheme)



- 2) 100 % Principle amount to be paid. The consumer may opt up to 6 monthly interest free installments.
- 3) Additional 5% rebate to HT and 10% rebate to LT consumers will be applicable if principal amount paid in one stroke.
- 4) If MSEDCL has filed suit for recovery, then consumer will have to bear all legal expenses along with principle amount and suit will be withdrawn thereafter. In such case if consumer opts for installment facility then Civil Suit will be withdrawn only after payment of entire principle amount with legal charges.
- 5) For reconnection consumer must pay at least 30 % payable principle amount plus legal charges if any and remaining amount may be paid in 6 equal installments.
- 6) For reconnection or new connection expenses for infra required if any, & reconnection charges and security deposit will be payable by consumer dealt as per the prevailing norms MSEDCL.
- 7) During the scheme period consumer should pay current bill and installments regularly. In case of default in current bill or installments, supply shall be disconnected.
- 8) During the scheme period no interests or DPC will be charged on installments (6 months) whereas the supply may be disconnected for nonpayment of installments in stipulated time.
- 9) To take the benefit of the scheme consumer has to pay all payable amounts (Principal arrears) within the months equal to no of installments opted. If Consumer fails to pay total payable PD arrears as per this Amnesty Scheme, the Interest and DPC will be applicable to defaulted amount.
- 10) The cases where decrees have been passed but not executed for a period of 12 years and no appeal is filed in before any court may be considered as eligible for the scheme.

- 10) The cases where decrees have been passed but not executed for a period of 12 years and no appeal is filed in before any court may be considered as eligible for the scheme.
- 11) The Cases where decrees have been passed and twelve years are not completed, amount payable will be as per Decree order, whereas he will be eligible for 50% rebate in interest if paid in one stroke.
- 12) The Consumers in Litigation will not be eligible for participation in this scheme.
